The TRCC was created to bring together agencies that are interested in reducing traffic injuries and deaths by improving the timeliness, accuracy, completeness, uniformity, integration, and accessibility of traffic records data.

Resources: Florida's Traffic Records System includes information on: Crashes; Roadways; Driver Histories; Vehicle Registrations; Citations, Prosecutions, and Adjudications (e.g., Enforcement); Injury Surveillance and EMS information; and Trauma Registry.
